This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. Section 4 - First Aid Measures

General Information:

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Evacuate the spill area and deny entry to unnecessary and unprotected personnel. Immediately call the Fire Brigade. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include Viton, Nitrile, butyl rubber, PE/EVAL, Responder. Eye/face protective equipment should comprise as a minimum, protective goggles. This product is toxic to aquatic organisms. Insufficient data to be sure of status.

Empty containers and any residual contents should be disposed of safely (e.g. by burying) as free Ivermectin may adversely affect fish or certain water-borne organisms.

Do not contaminate dams, rivers or streams.

In the presence of sunlight, residual Ivermectin will degrade in a short period of time. Contaminated water can be treated by carbon adsorption. Material should be disposed of in a landfill approved for pesticide containers.
